## Membership Fees and basic rules

**Single Membership** = \$115 per month = Yearly = \$1380 per year

**Family Membership** = \$115 per month + \$12.50 per family member (maximum 3 additional members)

**Club 54 Membership** = Yearly = \$600 per year = Discounted Green Fees

**Junior Membership** = \$300 per year - cart not included.

**Junior Membership (age13-18 per month) (children under 13 are free when with adult member). Full-time students ages 19- 24 may continue with junior membership fees but must furnish or rent a cart. Full-time student means you must be in High School or College and taking at least 12 hours each semester (on campus). Certain trade or vocational schools can be considered on an individual basis.**

**The above memberships exclude cart. Cooper's Hawk requires the member to furnish their own cart or pay the \$20 cart fee. Junior members pay a \$10 cart fee. Out of county members pay a \$18 cart fee.**

**CORPORATE MEMBERSHIPS WILL BE CONSIDERED FOR 3 OR MORE INDIVIDUALS ACTIVELY EMPLOYED BY THE SAME COMPANY.**

- **3 or more individuals receive a \$5 discount**
- **8 or more individuals receive a \$10 discount**
